The income based tuition scholarship program at the Early Childhood Development Center at Notre Dame (ECDC-ND) is based upon combined family gross income. To be considered for the 2009 Summer Program and/or the 2009-10 School Year tuition scholarship program, a copy of your **signed** 2008 Federal Income Tax Return and this form must be completed and submitted to ECDC-ND by the dates listed above (May 1 for the summer program and June 1 for the school year program). If your child is enrolled for both the summer and school year programs, only one submission of your 2008 Federal Income Tax Return with this form is required on or before May 1, 2009.

The tuition scholarship program is available to ND and SMC staff, students, administration and faculty. It is not available to ND and SMC Alumni(ae) and/or Holy Cross Order employees. Those who elect not to provide income information will be assessed the full tuition rate. Tuition rates are included on the ECDC website in the summer and school year program brochures at: [www.nd.edu/~ecdcnd/registration.html](http://www.nd.edu/~ecdcnd/registration.html).

Tuition scholarship eligibility is granted from the first day of the child's enrollment in the summer program or the school year program, whichever occurs first, through the 2009-2010 school year. Verification of combined family gross income is required on an annual basis.
