Gavin T. Colvert is Assistant Professor of Philosophy at Assumption College in Worcester, Massachusetts. His areas of research include ethics, political philosophy, medieval philosophy, and philosophy of religion. He has a special interest in a dialogue between the work of St. Thomas Aquinas and contemporary philosophy. He has published articles on the work of philosophical figures such as Aquinas, William Ockham, Jacques Maritain, and Hilary Putnam, among others.

John A. Cuddeback is associate professor of philosophy at Christendom College. His teaching and research focus on themes in ethics, especially natural law, common good, friendship, and contemplation. He is the author of *Friendship: The Art of Happiness*, as well as several articles.

Raymond Dennehy is a former president of the American Maritain Association and is professor of philosophy at the University of San Francisco where he teaches epistemology, metaphysics, political philosophy, and social ethics. In addition to publications in journals, he has published *Reason and Dignity, Anti-Abortionist at Large: how to argue intelligently about abortion and live to tell about it*, and edited *Christian Married Love*. Dr. Dennehy is frequently invited to address contemporary ethical and social issues on television, radio, and university campuses.

Bernard Doering is Professor Emeritus of Romance Languages and Literature at the University of Notre Dame. He has published two books about Maritain: *Jacques Maritain and the French Catholic Intellectuals* (1983) and *The Philosopher and the Provocateur, the Correspondence of Jacques Maritain and Saul Alinsky* (1994). In addition, he has translated books by and about Maritain.

Desmond J. FitzGerald Professor Emeritus at the University of San Francisco. He attended the lectures of Fr. Gerald B. Phelan at St. Michael's, University of Toronto, as an undergraduate in the 1940s. He holds a B.A. and an M.A. from Toronto and an M.A. in political science and a Ph.D. in philosophy from the University of California at Berkeley. He taught at the University of San Francisco from 1948-1998.

Sarah J. Fodor is an independent scholar and associate director of foundation relations at Northwestern University. She has published essays on Flannery O'Connor in *Flannery O'Connor: New Perspectives* (ed. Sura P. Rath and Mary Neff Shaw, 1996) and in *Literature and Belief* and the *Flannery O'Connor Bulletin*. Her book reviews have appeared in the *Anglican Theological Review* and *The Christian Century*.

William J. Fossati teaches history at Rockhurst University in Kansas City, Missouri. He earned his B.A. and M.A. degrees in history from the University of Arizona. He holds a Ph.D. in modern European history from Kansas University. His area of specialty is French history after 1789. He has done extensive research in the area of the history of ideas. His specific focus is on the period of the Catholic revival in France in the early twentieth century.

W. Matthews Grant is an Assistant Professor of Philosophy at the University of St. Thomas in St. Paul, Minnesota. He received his Ph.D. in Philosophy from Fordham University. His research interests include philosophy of religion, medieval philosophy, natural law ethics and contemporary Thomism.

Gregory J. Kerr is Associate Professor of Philosophy at DeSales University. He was former editor of the *Maritain Notebook*, the newsletter of the American Maritain Association.
